**Memorandum of Understanding for Improvement In Quality of
School Education Through Adoption of Ajmal Adarsha Jatiya Vidyalaya,

**This Memorandum of Understanding (MOU) is made on 22/12/2022
(Effective Date) By and Between:**

Nazir Ajmal Memorial College for Education (NAMCE), a college registered under Ajmal Foundation Trust Act bearing registration number 3480/176 having its registered office at Haji Ali Muffosil Complex, Hojai, India, represented by Dr Ashis Saha authorized by the Ajmal Foundation, Board of Trustees, which expression shall unless excluded by or repugnant in the context be deemed to include his successors and assigns (hereinafter referred as Nazir Ajmal Memorial College for Education).

AND

Ajmal Adarsha Jatiya Vidyalaya, Akashiganga (AAJV) represented by the Principal having its office at Tapaturi, Doboka, Parakhowa, Hojai-782441 through Mr/Ms Imran Hussain Mazumdar (which expression shall unless excluded by or repugnant in the context be deemed to include its successor and assigns).

Whereas Nazir Ajmal Memorial college for Education has informed Ajmal Adarsha jatiya Vidyalaya that it has the requisite experience and resources in terms of financial resources, human resources and expertise in providing and enhancing the quality of the academic and vocational education.

Whereas Ajmal Adarsha jatiya Vidyalaya wants to enter into an MOU for the scope and purpose as set forth in Clause 1 below.

Now therefore, in consideration of the mutual promises and undertakings contained in this MOU, the parties agree as follows:

1. Purpose, Scope of the MOU:

The MOU provides for:

- a) Improving the quality of primary to senior secondary (inclusive of vocational training at the 10+2 level) for students studying in the following school as per the time frame:

- b) Activities to be undertaken to improve the teaching infrastructure (includes libraries, laboratories etc), hygiene and sanitary facilities in the school and also make efforts at beautification of the schools premises.
- c) To support students with their education beyond school, two way approach would be adopted –i) remedial coaching for slow learners after school hours, in the school premises and ii) adult education classes for illiterate/marginally literate parents of students so that the students get a more suited environment for learning at home.

- d) To complement the governments interventions at introducing skill development opportunities for senior students in order to enhance their employability and instill in them an urge to work and earn from an early age, development of well designed practical learning labs for vocational trades being taught, facilitating industry tie ups for market aligned curriculum development, organizing industry exposure visits, etc. have been planned. Roles and Responsibilities of Nazir Ajmal Memorial College for Education, Hojai

The following shall be the roles and responsibilities of the Nazir Ajmal Memorial College for Education, Hojai, under this MoU.

1. The Nazir Ajmal Memorial College for Education shall periodically organize programs at the Ajmal Adarsha Jatiya Vidyalaya for capacity building amongst the teachers.

2. Workshops, Seminars, and any other program shall be organized by the Nazir Ajmal Memorial College for Education for training the teachers of Ajmal Adarsha Jatiya Vidyalaya on pedagogy.

3. The Nazir Ajmal Memorial College for Education shall periodically organize activities amongst the pupils of the Ajmal Adarsha Jatiya Vidyalaya on various curricular, co-curricular and extra- curricular aspects.

4. The Nazir Ajmal Memorial College for Education shall assist the Ajmal Adarsha Jatiya Vidyalaya in upgrading its library, classroom facilities and other essential infrastructure whenever necessary and possible to enhance the quality of teaching learning in the school.

5. The Nazir Ajmal Memorial College for Education shall monitor the academic progress and performance of the Ajmal Adarsha Jatiya Vidyalaya from time to time.
